# TEMPORARY 2009 BUSINESS CLASS MEMBERSHIP

## Description

Temporary Corporate Membership – For each full dues-paying member employed, each (Business Entity) will be able to add an individual under their employment into the temporary membership.

- no initiation fee, food minimum of \$50.00++ per month
- full use of the facility to include golf, pool, racquet and fitness
- not be responsible for debt repayment, no voting privileges
- prospective members under this category must not have been members of ECC within one (1) year from application

## MONTHLY DUES

Your membership has full use of the Clubhouse, Racquet, Pool, Fitness Facility, and Golf Course. You may bring the same guest four (4) times during the year to each of the sport venues upon payment of applicable fees.

- **dues \$235.00 plus tax per month**

## FOOD MINIMUM

It is anticipated that you will spend \$50.00 ++ towards food purchases each month. This does not include beverages that are generated at the bar. Food purchases made at the Snack Bar and Halfway House are credited towards your minimum.

- Minimum of \$50.00 + \$7.50 service charge + \$4.60 tax = \$62.10

Should you not visit the Club to use your minimum, your account will be billed the difference of what you do charge and the unspent portion at the end of the month.
