Thank you for your interest in the Elmira Country Club. If you have never been a member of the Elmira Country Club before, or you have not been a member for at least five (5) years from the date of your application, we are excited to be able to offer you the following special recruitment package.

- Initiation – one-time fee of \$500.00, submitted with your application
- Annual Dues - \$1,500.00 for the 1<sup>st</sup> year, which can be paid in equal monthly installments
- Dues Increase - \$500.00 a year until you reach the dues level for the membership class you qualify for
- Dues Assessments – waived for the 1<sup>st</sup> year
- Food Minimum - \$273.24 4-month post bill or \$819.72 annual fee
- Not eligible for the 25% discount offered under normal recruitment

**Full membership** to the Elmira Country Club includes either a golfing membership or a house membership. Both memberships include full use of the racquet facilities to include tennis courts, platform tennis (paddle) courts, squash court, pool and full fitness facility. If you choose a house membership, you will be limited to four (4) visits to the golf course during any given season upon payment of green fees and applicable cart charges. As long as the course is open for the season, you may still arrange for golf lessons through the club pro and the driving range is available to all full memberships either through a yearly fee or a charge per bucket to balls.

**Available under normal recruitment and has the 25% discount for the 1<sup>st</sup> year of membership.**

**The Dining/Social membership** is strictly for the restaurant, but also includes social events involving the clubhouse such as bridge, the Founder's Ball and Lobster Night. If you choose this category, you have unlimited guests privileges to the restaurant and social events only. If at sometime in the future you wish to use the other amenities of the Club, you would need to change your classification to either a house membership or golf membership.
