# TEMPORARY 2007 CORPORATE MEMBERSHIP

Once the application is returned to the office, there is a 21-day waiting period prior to acceptance. Your name will be posted for membership approval on the 7th day; on 21st day, you will be notified of acceptance. ***If you wish to have a Provisional Membership (allowing use of the club during the waiting period) a letter making this request, and signed by your proposer, must be submitted with your application to the club office.***

## Description

Temporary Corporate Membership – For each full dues-paying member employed, each Corporation (Business Entity) will be able to add an individual under their employment into the temporary membership.

- no initiation fee, food minimum of \$50.00++ per month
- full use of the facility to include golf, pool, racquet and fitness
- not be responsible for debt repayment, no voting privileges
- temporary membership will end April 30, 2009 at which time new member will switch to the appropriate classification with full responsibilities if he / she wishes to remain a member
- if the member under this class leaves the employment of the corporate member, current dues and assessments will be put into place
- prospective members under this category must not have been members of ECC within one (1) year from application
- ***offer to Corporations will end June 30, 2007***

## MONTHLY DUES

Your membership has full use of the Clubhouse, Racquet, Pool, Fitness Facility, and Golf Course. You may bring the same guest four (4) times during the year to each of the sport venues upon payment of applicable fees.

- **Join by March 31, 2007 – dues \$200.00 plus tax per month**
- **Join by June 30, 2007 – dues \$225.00 plus tax per month**

## FOOD MINIMUM

It is anticipated that you will spend \$50.00 ++ towards food purchases each month. This does not include beverages that are generated at the bar. Food purchases made at the Snack Bar and Halfway House are credited towards your minimum.

- Minimum of \$50.00 + \$7.50 service charge + \$4.60 tax = \$62.10

Should you not visit the Club to use your minimum, your account will be billed the difference of what you do charge and the unspent portion at the end of the month.
